Should the mare not conceive after two heat cycles, a veterinarian certificate shall accompany each mare prior to any additional collections or shipments. Shipments will be handled by FedEx next day delivery unless other arrangements have been made in advance. Runnin C Ranch is to be notified at least one day before semen can be shipped. Collection days are Monday, Wednesday and Friday only and must verify shipment by 8:00 am the morning of.

The 2024 breeding season will be from February 14, 2024 until April 26, 2024.

If frozen is available, the mare owner may order frozen semen at any time. 2 doses of frozen will be shipped per shipment at a rate of \$600 per shipment. Frozen may be picked up on a case to case basis and charged at a rate of \$150/dose + packaging/nitrogen fees if applicable.
