

I hereby agree to breed the mare \_\_\_\_\_ Reg # \_\_\_\_\_ to the stallion Perks On The Rocks\_ AQHA #\_5869433\_. The 2024 fee is \$1250\_ which includes the \$500 booking and \$200 chute fee. Packn will be ON FARM only for 2024.

The mare shall be in a healthy and sound breeding condition, including a current negative culture and biopsy. Should the mare not conceive after two heat cycles, a veterinarian certificate shall accompany each mare prior to any additional collections or shipments. Shipments will be handled by FedEx next day delivery unless other arrangements have been made in advance. **Runnin C Ranch is to be notified at least one day before semen can be shipped. Collection days are Monday, Wednesday and Friday only and must verify shipment by 8:00 am the morning of.**

The 2024 breeding season will be from February 14, 2024 until April 26, 2024.

If frozen is available, the mare owner may order frozen semen at any time. 2 doses of frozen will be shipped per shipment at a rate of \$600 per shipment. Frozen may be picked up on a case to case basis and charged at a rate of \$150/dose + packaging/nitrogen fees if applicable.

**PRE-BREEDING ARRANGEMENTS:** The mare owner must provide the following when making a booking:

1. Copy of both sides of registration certificate.
2. Copy of completed & signed breeding contract
3. All Applicable Fees:
  1. The booking fee is due with this contract to reserve your spot for 2024
  2. The balance of stud fee must be paid in full before any semen will be shipped.
  3. Any incomplete registration certification or unpaid charges will result in a hold of the mare's name on the appropriate stallion breeding report.
  4. Semen will not be shipped to any mare unless a current credit card number and expiration date is on file OR shipping prepaid.

**IMPORTANT. MUST READ:** By filling out, signing and returning this contract to Runnin C Ranch, I agree to the terms listed. I agree that I am solely responsible for carrying out my part as mare handler/owner. I agree that I am responsible for all of the financial duties listed in this contract. I have read and understand this contract in its entirety.

1. Live foal guarantee: Our live foal guaranteed is covered thru 30 days of age. If the foal does not survive until 30 days old, The mare owner will have the right to a rebreed the following season only following original contract season. Rebreeds must pay a rebreed chute fee of \$300 and any shipping/pick up charges applicable. If the mare owner fails to rebreed the mare the following year after original contract, does not provide proof in the above manner, or the foal dies after 30 days of age, then any and all fees become forfeited, the right to rebreed is cancelled and the stallion owner is released from all further obligation of this contract, unless otherwise agreed in writing and signed by both parties.

**\*\*NOTICE\*\*** Owners that choose to ride and/or compete on their mare during gestation may NOT be eligible for Live Foal Guarantee. This will be at the stallion owner's discretion.

**Payment Information:**

All payments may be made by cash, check, or with Visa, Master Card, or American Express credit cards. If paying by credit card, a 4% transaction fee will apply. If paying by check, simply leave credit card space below blank. All shipping and charge fees are subject to change (with notice). Payments must be made in full prior to semen shipped. Make payable to Runnin C Ranch.
