

I hereby agree to breed the mare \_\_\_\_\_ Reg # \_\_\_\_\_ to the stallion Okie Gypsy ApHC #691114. The 2023 fee is \$950 which includes the \$500 booking and \$200 chute fee. Cooled semen may be picked up at no additional cost. If shipping is needed, each shipment is \$300.

**Early Bird Booking Specials** – before October 1, \$750 or before January 1, \$850

The mare shall be in a healthy and sound breeding condition, including a current negative culture. Should the mare not conceive after two heat cycles, a veterinarian certificate shall accompany each mare prior to any additional collections or shipments. Shipments will be handled by FedEx next day delivery unless other arrangements have been made in advance. **Runnin C Ranch is to be notified at least one day before semen can be shipped. Collection days are Monday, Wednesday and Friday only and must verify shipment by 8:00 am the morning of.**

The 2023 breeding season will be from February 15, 2023 until April 28, 2023.

If frozen is available, the mare owner may order frozen semen at any time. 2 doses of frozen will be shipped per shipment at a rate of \$550 per shipment. Frozen may be picked up on a case to case basis and charged at a rate of \$100/dose + packaging/nitrogen fees if applicable.

**PRE-BREEDING ARRANGEMENTS:** The mare owner must provide the following when making a booking:

1. Copy of both sides of registration certificate.
2. Copy of completed & signed breeding contract
3. All Applicable Fees:
  1. The booking fee and stud fee must be paid in full before any semen will be shipped.
  2. Any incomplete registration certification or unpaid charges will result in a hold of the mare's name on the appropriate stallion breeding report.
  3. Semen will not be shipped to any mare unless a current credit card number and expiration date is on file OR shipping prepaid.

**Shipment Information:**

1. Semen will be sent via Fed-EX/ UPS (next day arrival) at a rate of \$300 per shipment within the U.S. This MUST be paid PRIOR to shipping of semen.
2. Mare owner is also responsible for blood typing or DNA testing their mare as per AQHA rule #209 or APHA rule RG-165.
3. Mare will not be put on a stallion breeding report until all fees have been paid in full including stud fee, shipping AND shipping container if applicable and last breeding date has been provided.
4. IT IS THE MARE OWNER'S RESPONSIBILITY TO LET US KNOW THE PREGNANCY STATUS OF THE MARE!
5. NOTICE: ALL UNRETURNED SHIPPING CONTAINERS WILL BE CHARGED TO THE MARE OWNER.

**IMPORTANT. MUST READ:** By filling out, signing and returning this contract to Runnin C Ranch, I agree to the terms listed. I agree that I am solely responsible for carrying out my part as mare handler/owner. I agree that I am responsible for all of the financial duties listed in this contract. I have read and understand this contract in its entirety.

1. Live foal guarantee: A live foal is defined as one that will stand and nurse up to 24 hours old. If foal is born dead, mare owner agrees to furnish the stallion owner, within 24 hours, photographic proof of the deceased foal. The mare owner will have the right to substitute a different mare for the rebreeding providing that the substitute mare is of the same quality and condition as the original mare approved, determined at the stallion owner's discretion. In such a case return privilege will be available for one additional season only following original contract season. Rebreeds must pay a rebreed chute fee of \$300 and any shipping charges applicable. If the mare owner fails to rebreed the mare the following year after original contract, does not provide proof in the above manner, or the foal dies after 24 hours post foaling, then any and all fees become forfeited, the right to rebreed is cancelled and the stallion owner is released from all further obligation of this contract, unless otherwise agreed in writing and signed by both parties.

\*\*NOTICE\*\* Owners that choose to ride and/or compete on their mare during gestation may NOT be eligible for Live Foal Guarantee. This will be at the stallion owner's discretion.

**Payment Information:**

All payments may be made by cash, check, or with Visa, Master Card, or American Express credit cards. If paying by credit card, a 3.5% transaction fee will apply. If paying by check, simply leave credit card space below blank. All shipping and charge fees are subject to change (with notice). Payments must be made in full prior to semen shipped. Make payable to Runnin C Ranch.
