Collection days are Monday, Wednesday and Friday only and must verify arrival by 8:00 am the morning of.

The 2024 breeding season will be from February 14, 2024 until April 26, 2024.

If frozen is available, the mare owner may order frozen semen at any time. 2 doses of frozen will be shipped per shipment at a rate of \$600 per shipment. Frozen may be picked up on a case to case basis and charged at a rate of \$150/dose + packaging/nitrogen fees if applicable.
