

This agreement is between _____ of _____, _____ and Chelsea Kroes of Loveland, Oklahoma, operating Runnin C Performance Horses LLC (and staff), for handling and/or the care of the mare _____ (and foal, if applicable) for any or all of the following services; boarding, foaling and/or breeding.

- 1) Upon arrival, the Mare (and foal) will be in healthy physical condition and sound breeding condition, free of any infectious, contagious or transmittable disease.
- 2) A copy of current negative Coggins test will be required before mare can be admitted.
- 3) Runnin C Performance Horses LLC agree to provide suitable facilities for the care of the mare (and foal). The mare owner agrees to pay for the services as follows:
 - a. Mare Care Dry - \$20/day
 - b. Mare Care Wet - \$25/day
 - c. \$300 per cycle fee – includes ultrasounds, first insemination and ovulation agent.
 - i. If an additional insemination is needed in the same cycle, the fee is \$50 per additional insemination.
- 4) Extra fees that may be applicable to Mare Owners from Runnin C Performance Horses LLC would be as follows:
 - a. Lutalyse Injection - \$10
 - b. Deslorelin - \$65
 - c. Sedation (if needed) - \$30
 - d. Staples (if needed) - \$30
 - e. Opening Caslicks (if needed) - \$30
 - f. Regumate (if needed) - \$6/day
 - g. Banamine Injection (if needed) - \$10
 - h. Lavage (if needed) – 1L \$55 + antibiotics
 - i. Additional Fluids (if needed) - \$13/L
- 5) If Runnin C Performance Horses LLC is unable to obtain a pregnancy after two attempts on a Mare, it is recommended the Mare Owner have a veterinarian do a breeding exam on the mare, at the mare owner's expense.
- 6) Waiver of liability. The mare owner agrees to assume all risk of death, sickness or injury to the mare (and foal).

- 7) In case of an emergency situation, what number are we able to call you at at any hour of the day? _____.
- 8) If Runnin C Performance Horses LLC feels the mare (and/or foal) need to be seen by a veterinarian and can not get in contact with the mare (and foal) owner, Runnin C Performance Horses LLC has the right to call a Veterinarian out and the mare (and foal) owner will be responsible for the entire bill. In this case, Ruinnin C Performance Horses will only have the veterinarian do what is necessary to keep the mare (and/or foal) comfortable until the owner can be reached. _____ (Initial here)
- 9) If Runnin C Performance Horses LLC cannot get in contact with the mare (and foal) owner in an Emergency situation, do you wish to have Runnin C Performance Horses LLC do all that is necessary to try to save the mare? _____. Do you wish to have Runnin C Performance Horses LLC do all that is necessary to try and save the foal? _____. Mare (and/or foal) owner understands that they are responsibe for all bills involved. _____ (initial here). - 10) All care and bills must be paid in full prior to moving the mare (and foal). All unpaid balances are subject to 3% interest rate starting after 30 days. There will be \$100 charge for bad checks.
- 11) Mares must be picked up on or before Friday, May 12, 2023. If the entire bill is not paid in full and the mare is not picked up by May 12, 2023, the mare owner will relinquish ownership of the mare to Runnin C Performance Horses LLC and will provide the registration papers and a signed transfer.

At drop off we will require the first \$300 cycle mare management fee, as well as the first 30 days of mare care paid up front. If the mare stays less than 30 days, Runnin C Performance Horses LLC will credit back the mare owner the difference between the 30 days paid up front and the actual number of days stayed.

If the mare stays longer than 30 days, the mare owner will need to pay the second month of mare care up front. Same rules apply, if the mare stays less time than the pre paid mare care payment, Runnin C Performance Horses LLC will credit back the difference of days stayed vs days paid for to the mare owner.
