

I hereby agree to breed the mare \_\_\_\_\_ Reg #\_\_\_\_\_ to the stallion \_Perks Firewater Flit\_ AQHA #4611609. The 2023 fee is \_\$2500\_ which includes the \$500 booking and \$200 chute fee. The chute fee includes the collection of semen and artificially inseminating the mare. All breeding and boarding services are at an additional cost.

The \$500 booking is all that is required with the signed contract. The \$2000 balance must be paid before or at the time of the mare's drop off.

**The 2023 breeding season will be from February 15, 2023 until April 28, 2023.**

This is for **ON FARM** breeding only at Runnin C Ranch in Grandfield, Oklahoma. **Runnin C Ranch is to be notified at least one day before the mares arrival. Collection days are Monday, Wednesday and Friday.** The mare shall be in a healthy and sound breeding condition, current on vaccinations, dewormed within 30 days, have a current negative coggins and a current negative culture.

It is also agreed to have a veterinarian/repro specialist check the mare for breeding conditions and to perform such other repro/veterinary services at the expense of the mare owner. It is understood that Runnin C (Chelsea & Calvin Kroes) will not be responsible for accident, sickness or death to a mare and/or foal. Runnin C (Chelsea & Calvin Kroes) will exercise their best judgement in the care and supervision of the mare and/or foal. All boarding fees and additional expenses shall be paid before the mare leaves Runnin C Ranch.

**PRE-BREEDING ARRANGEMENTS:** The mare owner must provide the following when making a booking:

1. Copy of both sides of registration certificate.
2. Copy of completed & signed breeding contract
3. All Applicable Fees:
  1. The booking fee is due now and the balance of the stud fee must be paid in full before the mare arrives.
  2. Any incomplete registration certification or unpaid charges will result in a hold of the mare's name on the appropriate stallion breeding report.

**IMPORTANT. MUST READ:** By filling out, signing and returning this contract to Runnin C Ranch, I agree to the terms listed. I agree that I am solely responsible for carrying out my part as mare handler/owner. I agree that I am responsible for all of the financial duties listed in this contract. I have read and understand this contract in its entirety.

1. **Live foal guarantee:** A live foal is defined as one that will stand and nurse up to 24 hours old. If foal is born dead, mare owner agrees to furnish the stallion owner, within 24 hours, photographic proof of the deceased foal. The mare owner will have the right to substitute a different mare for the rebreeding providing that the substitute mare is of the same quality and condition as the original mare approved, determined at the stallion owner's discretion. If for any reason the stallion is deceased or unfit to breed, the mare owner may use the rebreed to one of the other stallions owned by Runnin C

Ranch. In such a case return privilege will be available for one additional season only following original contract season. Rebreeds must pay a rebreed chute fee of \$300 and any shipping charges if applicable. If the mare owner fails to rebreed the mare the following year after original contract, does not provide proof in the above manner, or the foal dies after 24 hours post foaling, then any and all fees become forfeited, the right to rebreed is cancelled and the stallion owner is released from all further obligation of this contract, unless otherwise agreed in writing and signed by both parties.

\*\*NOTICE\*\* Owners that choose to ride and/or compete on their mare during gestation may NOT be eligible for Live Foal Guarantee. This will be at the stallion owner's discretion.

**Payment Information:**

All payments may be made by cash, check, venmo, paypal, cash app, zelle or Square/credit card. If paying by credit card, a 4% transaction fee will apply. Any electronic payment fees must be paid for by the mare owner.

Payments must be made in full prior to mares arrival. Make payable to Runnin C Ranch.
